II. Course Description:

This is an introductory course to the linguistic structures of English language at the levels of morphology and syntax. The course will be divided into two parts. In the first part, the students will learn about the word structure, word analysis and the different processes of word formation in English language. In the second part, they will move syntax in which they will learn about the English sentence structure, the different constituents of the sentence and the different processes of analyzing English sentence into its minimal parts. By the end of

the course, the students will be able to distinguish between the structures of English and Arabic languages which will help them in using English correctly in different situations for different purposes.
