II. Course Description:

This course is meant to introduce the students to the phonetic and phonological features of English language. It provides the students with the different kinds of sounds in English, their places and manners of production. The students will learn about the consonant and vowel sounds from a phonetic and phonological views. Also they will learn about the suprasegmental aspects of English like stress, intonation and the syllable. By the end of the course, the students will be able to produce the sounds of English perfectly. Also they will be able to distinguish between the Arabic and English sound systems which will help them in avoiding the influences of their L1 in speaking English. The course will be enhanced by extensive practices and oral production tasks.
